FD 36" DEEP THE CUT LIMESTONE IN EXCELLENT CONDITION. A SHREADED CARSONITE WAS LAYING ON TOP OF L.S. & OLD METAL FENCE POST WAS ON THE SOUTH SIDE AND THE TOP 3' WAS BENT NORTHERLY ON WEST SIDE OF L.S. PLACED TWO MAGNETS NEAR TOP OF L.S. & ALUM ON TOP OF CUT LS. PLACED CARSONITE ON SOUTH SIDE OF L.S. FD CUT CROSS ON TOP OF LS.
