IN THE 1970'S, W.D.O.T. RECONSTRUCTED C.T.H. B. AT THIS LOCATION THERE IS AN EXTREMELY LARGE AMOUNT OF FILL. I ACCEPTED LEE'S 1973 PLACEMENT OF THE CORNER BUT DID NOT INSTALL A MONUMENT OR REFERENCE THE CORNER LOCATION.
