<u>Approval of Agenda</u>: Supervisor Owens approved the agenda, seconded by Citizen Representative Weaver-Landers with unanimous approval. APPROVED.

<u>Approval of Minutes of Human Services Board meeting of November 25, 2009</u>: Supervisor Wopat moved the minutes be approved as presented, seconded by Supervisor Grahn with unanimous approval. APPROVED.
