\$80 was added to Lutheran Social Services. This \$80 was for an additional clothing and personal amount for one consumer.

An amount of \$2,210 for Root, Wade and Lisa should have been to Rutkowsky, Eric or Mandy. The name was changed before the check will be sent out.

An amount of \$2,767.50 for Welter, Ralph & Sue was changed to \$2,662.50. The consumer is currently in a hospital, the reduction in the amount is the consumers clothing and personal amount and the transportation dollars to the workshop was deleted.

Secured Living LLC will receive an additional \$34,141 for CY 2009. A Brain Trauma consumer was placed mid year in 2008 but not fully annualized for 2009.

Secured Living LLC will also receive an additional \$73,559 for CY 2009. This is for one CIP 1B client moving into services from another facility, an increase in the care rate of one CIP 1B client, and an increase of services for 2 CIP 1B clients.
