I wish to speak during Citizen Participation on the following item: - To Whom It May Concern, I wish to express my comments during the next Rock County Board Meeting on June 25th, 2020 reference the Rock County Stands Against Racism tshirts that were designed. I had filled out the form to do so, but there was no place to actually write my comments. I wish to have the following read if possible into the meeting minutes.

My name is Amanda Johnson, I am a city of Milton resident, a Rock County 911 dispatcher, and wife to Milton police officer. I have worked for this county for 12 years. I am completely heartbroken at Rock County's decision to make this shirt. This shirt does not represent anything except for the Black Lives Matter agenda. The names on this shirt do not represent racism issues with the exception of possibly 2 names, Trayvon (killed by a hispanic male) and Ahmaud (killed by white father/son duo). The other names, NONE of them were killed because of their race. They were either justly killed due to their actions, cleared by several courts of law as reasonable and justified, died by their own hand (suicide of Sandra Bland) which was due to her own hand and she was not found because of lack following policy on inmate checks and not being caught as a suicide risk, not due to her race. Same with the poor child that was killed as a result of a search warrant. She did not die due to her race, she died due to a search warrant being issued at a house harboring a criminal hiding out. If Rock County stands against racism, then put actual racism cases on these shirts, represent ALL races affected by it. ALL RACES who have suffered because of it. Why did Rock County choose to put names of criminals on here who died at the hands of officers defending themselves? This is a slap in the face to every single officer and deputy who fight every day to protect our county. Those same individuals who have helped to create community programs, volunteer to work with the community on days off, be a part of the very communities they work in. By allowing these shirts to have been created and worn, you, Rock County Board members and the members of the Diversity/Cultural committee have sent a very clear message to those very individuals you ask to keep you safe. You are telling that they you stand with criminals who look to harm citizens and law enforcement, the same criminals who fought to kill them, kill the very officers you ask to keep you safe. You are telling officers and deputies their lives do not matter, their actions don't matter, the effort they put into the communities do not matter. Why would our law enforcement units ever trust us again? Why would they ever trust that we will support and assist them when they need it. These shirts you have created have sent a very loud and clear message. You will stand to support criminals who put their lives at risk to harm the very heroes who would die for you and your family if that is asked for them. My husband and his fellow officers and deputies would lay their lives down without hesitation to keep you safe...and you choose this agenda to let them know that you do not care. My heart is so broken. I am so embarrassed and ashamed to be associated with this decision. How dare you tell these units working day and night, even sending them into other communities like Madison and Milwaukee to protect those citizens, that their lives do not matter. You'd rather throw your support behind the very people our heroes fight to protect you from. You owe an apology to every police department, fire/EMS department, and the Rock County Sheriff's department for your actions and to their families who also sacrifice their lives so that their loved ones can keep you safe day and night, weekends, holidays, etc. Thank you for your time and for listening. Please help to be productive in all aspects of our community. Stand behind

actual racism, not these cases.
