<u>Update on the May/June Election Costs – Lori Stottler.</u> Ms. Stottler said she is estimating that she will be about \$40,000 over budget when all is done for the year. She added that the cost for all of Rock County for the May election was about \$176,000.

Options for Transferring Money to United Way – Lori Stottler. Ms. Stottler said she and Mr. Osborne have met with the United Way and was asked if it would be possible to have the cash converted to a check for them to pick up. Ms. Stottler asked if it was possible to have a checking account for the County Clerk's Office for things like the United Way and passport fees. Ms. Oja said she is not in favor of opening separate checking accounts. Ms. Oja suggested having a separate balance sheet account for the United Way, which would cost a bit for employee time.

Supervisor Podzilni suggested having this as an action item on the next agenda.

Mr. Knutson asked Ms. Oja to look into this and also to look into having the Treasurer's Office deposit the cash and write a check.
