<u>Citizen Participation, Communications and Announcements.</u> Ms. Brown informed the Committee that she had attended the WCA Tax Finance Meeting the prior day.

Review of 2013 \$6 Million Capital Improvement Debt Issue – Carol Wirth, President, Wisconsin Public Finance Professionals, LLC. Ms. Wirth handed out her Report on 2013 Financing –Highway Reconstruction and Connector Projects - \$6,040,000 G.O. Promissory Notes. Ms. Wirth went over the capital projects the County Board approved for 2012 and 2013 borrowing. Ms. Wirth went over the Federal Arbitrage Regulations – Tax-Exempt Debt; Source and Application of the Funds; the 2013 Financing Details; Estimated Debt Service Schedule; Estimated Pricing Summary; and the Combined Existing and 2013 Debt Service Schedule.

<u>Semi-Annual Report – Attendance at Conventions/Conferences.</u> The Committee accepted the Semi-Annual Reports from the County Clerk, Finance, Information Technology, Land Records, Register of Deeds and Treasurer and asked for them to be placed in file.

<u>Discussion and Possible Action on Updates to the Purchasing Manual.</u> This item was postponed to a future agenda.

Report on Cash Balances and Investments. Ms. Oja updated the Committee on cash balances and investments for June 30, 2013.

Ms. Oja also handed out copies of the County Sales Tax Receipts through June 2013.
