<u>Request for Reimbursement – Faulty Data Disc.</u> Supervisor Podzilni moved to reimburse \$235.27 to Michael Ettner, second by Supervisor Kraft.

Ms. Schultz and Ms. Borlick explained that a disc was ordered, the information on it checked, and the engineering company picked it up. The engineering company called on May  $22^{nd}$  to inform Ms. Borlick that the disc did not work. The engineering company was offered a new disc, however, they asked for a refund of \$235.27 instead. Ms. Borlick said they discussed the refund request with Mr. Dumas, Corporation Counsel, and he suggested the request come before the Finance Committee. Ms. Schultz said the disc was at 12" imagery and she had

previously informed the engineering company that the same information was available online at 18" imagery at no cost.

The Finance Committee discussed that the disc did work when it left the office, that it had been written on a "Read-Write" disc, so the department did not know if the engineering company may have written over the information, and why the engineering company had plenty of time to have the problem rectified before they made the call on May 22<sup>nd</sup>.

Motion FAILED on the following vote: Yes – Supervisor Kraft; No – Supervisors Podzilni, Beaver, Fox and Mawhinney.

<u>Approval of GIS Data Pricing Structure Changes.</u> Supervisor Fox moved approval of the amended GIS Data Pricing Structure, second by Supervisor Beaver. ADOPTED.

Chair Mawhinney suggested the departments use non-rewritable discs in the future.

Report on Cash Balances and Investments. Ms. Oja handed out copies of the County Sales Tax Receipts report and went over it. Ms. Oja updated the Committee on cash balances and investments as of May 31, 2012.

<u>Adjournment</u>. Supervisor Fox moved adjournment at 8:30 A.M., second by Supervisor Beaver. ADOPTED.
