10.A. The Condition of Education – Dr. Tom Eckert, Blackhawk Technical College.

Supervisor Bostwick introduced Dr. Tom Eckert as the President at Blackhawk Technical College. Dr. Eckert shared the following information on the Wisconsin Technical College System and Blackhawk Technical College:

At the National level, graduation rates from high school just 73.4%; Wisconsin has the highest rate in the Nation at 87.5%. Graduation rates range from 87.5% to 55.8% (Nevada). Districts vary considerably and some inner-city and remote rural districts have graduation rates as low as 35%.

The Wisconsin Technical College System includes 16 technical college districts with 48 campuses. More than 400,000 persons are educated annually at one of the above colleges in more than 300 different career and technical programs. Between 2004 and 2009, 98% of those educated at the Technical College system are employed, 90% work in Wisconsin and the median salary is \$40,000.

40% of all courses offered are at night or through some alternative delivery method. 38,000 students holding bachelor degrees are enrolled in the technical colleges. Over the past five years, enrollment has hiked 26%. The average age of technical college students are 32.7% are age 16-25, 49.3% are age 26-49, and 18% are over 50 years of age. Gender is roughly half and half with 49.9% being men and 50.1% being women. 14.8% of students are classified as minority and 3.9% self-identify with a present documented disability.

Blackhawk Technical College has a central campus, a branch campus in Monroe and three educational centers known as the Center for Transportation Studies, Aviation Center at Southern WI Regional Airport and Beloit Center at the Eclipse Center in Beloit. The college offers 30 two-year associate degrees, 4 two-year technical diplomas, 9 one-year technical diplomas, 8 less than one-year technical diplomas, 32 certificate programs, 5 apprenticeships in electrical/plumbing/millwright and GED/HSED and ESL.

In any given day, there are 6,000 students on BTC campuses. BTC's current graduation rate is 41% which is an area the College is seriously working to improve. During the recession of 2007-2009, BTC enrollment rose 54%. Tuition for WI residents is \$106 per credit and \$159 per credit for out of state students. Books average \$65 to \$75 but some cost as much as \$150. Total cost varies from program to program due to the number of credits required and the fees associated with the various programs.

BTC has 230 full-time employees, 190 part-time staff and 322 adjunct or part-time faculty, for a total of 750 (+ or -) individuals working for BTC in any given year. In the future, BTC will enter a strategic planning phase to create a five-year plan for the future.
