1. CALL TO ORDER

The meeting of the Rock County Planning & Development Committee was called to order at 9:00 a.m. on Thursday, December 15, 2016 at the Rock County Courthouse. Chair Alan Sweeney presided. Supervisors present: Wayne Gustina, Jason Heidenreich, Wes Davis, Mary Mawhinney. QUORUM PRESENT.

2. ADOPTION OF AGENDA

Adoption of the agenda moved by Supervisor Gustina, Seconded by Supervisor Mawhinney. Agenda ADOPTED (5-0)

Motion made by Supervisor Davis to accept the November 10, 2016 meeting minutes, Seconded by Supervisor Mawhinney. APPROVED (5-0)

5. CODE ADMINISTRATION AND ENFORCEMENT

A. Public Hearing – Shoreland Conditional Use Permit 2016 006 – Fulton Church

Moved to go into Public Hearing by Supervisor Gustina, Seconded by Supervisor Heidenreich. Role taken, all present, Time in: 9:03 am.

Mr. Baker described the project explaining the setbacks, height of building and layout and design as well as vegetation along the riverbank and proximity to Murwin Park.

Discussion followed. Ron Combs presented a plan map to the committee that illustrated the size and position of the new proposed building addition.

Mr. Baker and Mr. Byrnes elaborated on several issues affecting the project including an explanation of the Memo of Understanding with the Town of Fulton.

Concerns were raised about the vegetation on the riverbank, and Parks Director Lori Williams spoke to the fact that revegetation was one of the conditions of approval for the project, and that she will monitor.

Moved to go out of public hearing by Supervisor Mawhinney, Seconded by Supervisor Gustina. Time: 9:12 am.

B. Review and Approval, Approval with Conditions or Denial of Shoreland Conditional Use Permit 2016 006 – Fulton Church

Moved to approve made by Supervisor Mawhinney, Seconded by Supervisor Gustina. Chair Sweeney and Supervisor Gustina moved and seconded the motion to approve, but with supervisor Mawhinney reading the factors to consider when granting a Conditional Use Permit from the staff report (pages 11-12) that included language associated to revegetation plan. Approved (5-0)

C. Public Hearing Rock County Farmland Preservation Plan 2013 Plan Map Amendment

Moved to go into Public Hearing by Supervisor Davis, Seconded by Supervisor Gustina. Role taken, all present, Time in: 9:25 am.

Mr. Byrnes explained the amendment and the background on the Town of Janesville actions that required the amendment.

D. Approval and Recommendation to the Rock County Board Farmland Preservation 2013 Update Map Amendment Resolution

Moved by Supervisor Heidenreich, Seconded by Supervisor Mawhinney. Approved (5-0)

E. Citizen Objection to Rock County Address Ordinance Sec. 4.604 Address Numbering and Sec. 4.605 Address Signs:

Each of the citizens below provided their objections, concerns, and feedback as it pertained to their individual situation on the re-addressing of their homes. The results are listed under their names.

David & Nanette Rosinski Motion to Adhere to the Rock County Addressing Ordinance 4.604 made by Supervisor Heidenreich, Seconded by Supervisor Sweeney. Passed (3-2)

Rexford & Rebecca Nodorft

Motion made by Supervisor Davis to look into ways of compensating the Nordorfts for masonry changes and expenses. Motion failed by lack of a Second.

Discussion followed. Supervisor Mawhinney made a Motion to adhere to the Rock County Addressing Ordinance 4.604. Seconded by Supervisor Heidenreich. Passed (3-2)

Bruce & Anita Prinner

After Discussion, a Motion was made by Supervisor Sweeney to postpone decision until after the Prinners neighborhood addresses were reviewed and verified that the block ranges and address re-assignment regarding the Prinner's property were properly made. Seconded by Supervisor Heidenreich. Passed (5-0).

Laurie Valley

After Discussion, Supervisory Mawhinney moved to leave the address as 7905 with the stipulation that if any development occurs, then Ms. Valley's address would be changed. Detailed discussion followed. Motion failed for lack of a second.

A new Motion was made by Supervisor Heidenreich to leave the address as 7905 with the stipulation that if any development occurs Ms. Valley's address would be changed to an appropriate even number (7906). This would be initiated by a Recorded document with the Rock County Register of Deeds with Ms. Valley responsible for the recording fee. Staff to assist if needed. Passed (4-1).

F. Change of Use on Access Controlled Highway –Traynor Property, Driveway located at 7102 E County Hwy N, Milton Township

Mr. Baker discussed the history of this request and the need for the conversion of driveway to the Committee.
