

10. Rock Haven Project Update - Sherry Gunderson

Construction is nearly complete on our new nursing home. The building will be released to the County on Friday 2/15/13. Unfortunately, the stairs to our four mechanical rooms (one over each neighborhood) did not meet code and must be removed and recreated. That project will take approximately two months. During that time, CG Schmidt staff will complete several other projects including the household porches, the call light system and the electrical and cable hook-ups for the living room TVs.

While we wait for final completion of construction, we will be working with Mulrooney moving to move new furniture and equipment currently stored in the health care center to our new building. We will also be moving non-essential items from this building. We have been busily cleaning and packing for months. We have booked Mulrooney Moving staff for March 5 and 6,

April 9 and 29 and May 13, 14 and 20 for our move.

Deliveries of beds, appliances, window treatments, office furniture and other furnishings and medical equipment are scheduled beginning February 18th. Our maintenance and environmental services staff will be very busy unpacking and assembling furniture. All furnishings will be in place by late April. We will be using RECAP workers to assist with some of these projects.

Staff training has begun in the new building. Maintenance staff has received training related to our new mechanical equipment, fire and paging systems and geothermal system. Dietary and environmental services staff will be receiving training on their new equipment.

Staff tours have been scheduled for the last week in March. Staff training on fire safety and our disaster plan will be held in the new classroom in April. Resident and family tours are scheduled for late April.

Health Services Committee will begin meeting in the new administrative conference room with their April 10th meeting. They suggested that plans be made to hold the April 25th County Board meeting in our new multipurpose room with tours offered at the beginning of the meeting. They suggested that an earlier start time might be an option.

We will be moving our residents the morning of Monday, May 13 beginning at 8:30 am. We will be asking family members, volunteers and other county employees to assist us that morning. Volunteers will be used to assist staff to push residents to their new home.

At the conclusion of Ms. Gunderson's update, several supervisors suggested that a tour be given to the County Board prior to the transfer of residents. Supervisors Grahn and Bussie moved to hold the 2nd meeting in April at the new Rock Haven facility. Corporation Council Kuglitsch informed the chair that such a motion is out of order because it is not on the current agenda for a vote. He also informed the chair that the chair can call a meeting in any location. Chair Podzilni concluded that the item would come before the board for discussion at the next meeting.
