CODIFICATION SUBCOMMITTEE September 4, 2012

Chair Podzilni called the meeting of the Codification Subcommittee to order at 8:40 a.m. on Tuesday, September 4, 2012 in the Law Library - Fifth Floor of the Rock County Courthouse-East.

Members present: Supervisors Sandra Kraft, Louis Peer and Russ Podzilni. Also present: Jerome A. Long, Deputy Corporation Counsel.

<u>Approval of Agenda</u>: Motion by Louis Peer and seconded by Sandra Kraft to approve agenda. Adopted.

Approval of Minutes of August 28, 2012: Motion by Louis Peer and seconded by Sandra Kraft to approve minutes. Adopted.

Review of Previous Requested Changes: Jerry Long stated that he had looked into the clarification requested by the Committee to Chapter 2, 2.102 Mileage. It now reflects that the determination is in accordance with the Rock County Administrative Policy and Procedures Manual.

Jerry advised that Chapter 2 now contains 2.104 County Board – Apportionment of Districts from which Supervisors are Elected (Maps), as requested by the Committee.

<u>Discussion and Possible Action of Chapter 3 – Public Peace and Order:</u> The Committee reviewed and discussed the proposed Chapter 3. Jerry explained that the proposed 3.204 has been revised to streamline and address all issues with State Alcohol Beverage Law. Supervisor Kraft questioned the need for 3.206(6), 941.23 Carrying Concealed Weapon. Jerry explained that section has been removed from the proposed Ordinances. In Section 3.212, the Committee requested Jerry compare the area description in (2) with the Slow-No-Wake Ordinance. Supervisor Peer asked if 3.2061 could be renumbered to 3.207 and each Part 2 section following consecutively thereafter. The Committee discussed Part 4 – Carnivals and requested that in 3.402 Jerry replace references to cars with the word vehicles and that he draft a definition for what 'carnival' would be.

Jerry explained to the Committee the differences between County Ordinances and adopting State Statutes and how they played a role in the ordinances.

Supervisor Kraft requested Jerry to review for relevance 3.104(1), Regulations as to Parking at County Building in Beloit and 3.105(2) as to whether an abandoned vehicle must be moved in 24 or 48 hours.

The next meeting will be held on September 11, 2012 at 8:30 a.m. in the Law Library of the Rock County Corporation Counsel.

Motion by Louis Peer and seconded by Sandra Kraft to approve the proposed Chapter 2 – Administration. Adopted.
