10.A. <u>Report on the Bearcat Vehicle and Equipment – Sheriff's Office (The Bearcat will be</u> <u>available for viewing starting at 5:30 P.M. in the upper East parking at the Courthouse)</u>.

Captain Curt Fell and Captain Todd Christiansen of the Rock County Sheriff's Office (SWAT Command) presented the Bearcat Armored Rescue Vehicle. The Bearcat vehicle was a collaborative purchase between the Rock County Sheriff's Office, the City of Beloit Police Department and the City of Janesville Police Department. A joint operations manual has been established for use by all agencies. The purchase of the vehicle was paid for from seized assets

and forfeitures from arrests only totaling \$195,000. No tax dollars were used to purchase this vehicle.

The Bearcat stands for: <u>Ballistic Engineered Armored Response Counter Attack Truck</u>. The purpose of such a vehicle is for the rescue of citizens and officers. The vehicle provides ballistic protection for law enforcement and is designed to stop the firearms threat most encountered by law enforcement. It is utilized for most barricaded subjects, warrant services, hostage situations and anytime the threat of firearms exists.

Rock County is not the only agency to own such a vehicle. The 2005 Bearcat model is owned by Dane, LaCrosse, Eau Claire, Douglas, Oneida, Winnebago, Marathon Counties and the City of Milwaukee. Depending on the situation, additional bearcats are available through collaborative response. Rock County's Bearcat is a 2009 model.

Incidents where armored vehicles such as the Bearcat were used in recent events include:

- In 2010, four armored vehicles were used in a hostage/barricade situation where the Walworth Peacekeeper was shot several times.
- Tyler Texas Shooting Incident where 36 rounds of rifle fire was shot by murder suspect, yet no officers were injured and suspect was apprehended.
- Most recently, the media showed several armored vehicles in the Boston Marathon Response.

The Rock County Sheriff's Office and its partners are pleased with the acquisition of this vehicle and believe it will benefit the community in law enforcements ability to respond to threats timely and safely. Cpt. Christiansen also demonstrated for the Board of Supervisors a newly acquired robot that will be utilized as a "go-ahead" vehicle to clear rooms before response members to ensure the rooms are cleared and safe to proceed.

Subpart 2: Zoning of County-Owned Lands

4.217 Statutory Provisions and Statement of County Policy

(1) Subsection 59.69(9) of the Wisconsin Statutes provides as follows: with regard to the Zoning of County-Owned Lands:

- (A) The County Board may by ordinance zone and rezone lands owned by the County without necessity of securing the approval of the town boards of the towns wherein such lands are situated and without following the procedure outline in sec. 59.69(5), Wis. Stats., provided that the County Board shall give written notice to the town board of the town wherein such lands are situated of its intent to so rezone and shall hold a public hearing on the proposed rezoning ordinance and give notice of such hearing by posting in 5 public places in the town.
- (B) This subsection shall not apply to land that is subject to a town zoning ordinance which is purchased by the county for use as a solid or hazardous waste disposal facility or hazardous waste storage or treatment facility, as these terms are defined under sec. 289.01, Wis. Stats.

(2) If current land uses and Town designated zoning do not correspond on Countyowned lands the Planning and Development Committee will seek to zone the property within the context of Town Zoning Authority.
