FINANCE COMMITTEE Minutes – November 7, 2019

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, November 7,-2019, in the Conference Room N-1, Fifth Floor, Courthouse-East.

<u>Committee Members Present.</u> Supervisors Mawhinney, Beaver, Podzilni and Yeomans.

Committee Members Excused: Supervisor Fox.

<u>Approval of Agenda</u>. Supervisor Beaver moved approval of the agenda, second by Supervisor Podzilni. ADOPTED.

<u>Citizen Participation, Communications and Announcements.</u> Ms. Roettger said 19 properties went to the foreclosure auction, two in Town of Beloit were not bid on, the Town of Milton lot had been sold for \$1 they backed out of and it came back to the County, and the two lots sold together in Town of Lima is still unpaid at this time.

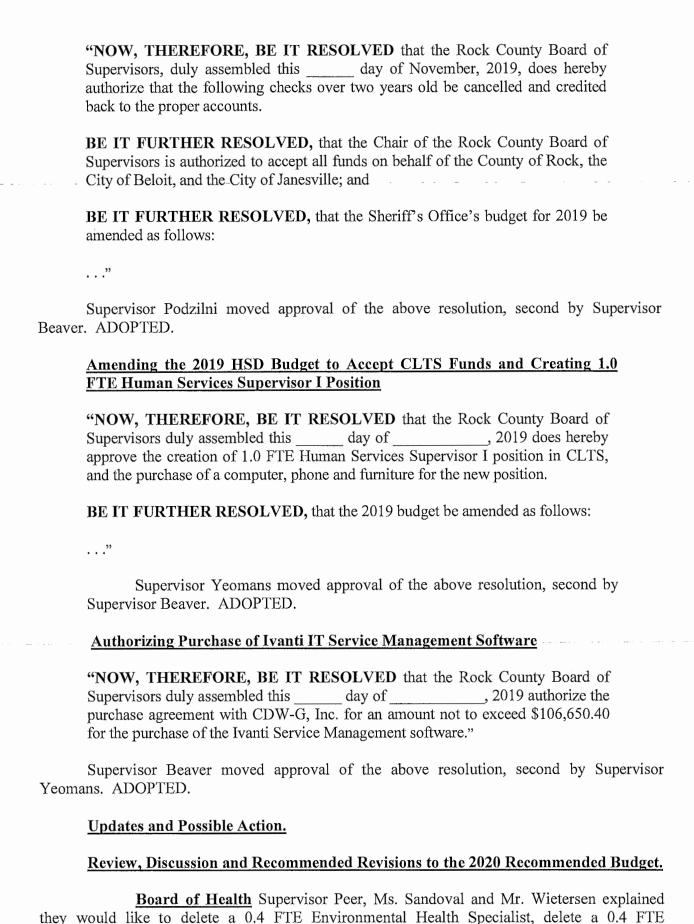
<u>Approval of Minutes – October 3, 2019 and October 16, 2019</u>. Supervisor Yeomans moved approval of the minutes of October 3, 2019 and October 16, 2019 as presented, second by Supervisor Podzilni. ADOPTED.

Transfers and Appropriations. None.

Committee Review and Approval of Per Meeting Allowances. Supervisor Podzilni moved approval of per meeting allowances in the amount of \$10,991.64, second by Supervisor Beaver, ADOPTED.

Resolutions and Committee Endorsements.

Cancellation of Checks Over Two Years Old



Environmental Health Technician and create a 1.0 FTE Environmental Health Specialist II. They said this would require an additional \$31,130. They went over the request from the packet explaining the expected grants and awards, some of which they have already received award letters for; the additional 2020 funding; part-time versus full-time work done by employees; discussed how often we lose a good employee because they have found a full time position; and the two part-time positions are both open at this time.

- Discussion on the use of grant funds in future to fully fund this position.

Supervisor Beaver moved to approve increasing the Board of Health payroll/benefits account using revenue from the State of \$31,130, second by Supervisor Yeomans. ADOPTED.

Public Safety & Justice Committee Ms. Timmerman handed out and went over her appeal to have two of her Deputy Register in Probate positions reallocated from Level 4 to Level 3. She said the staff in these two positions perform essentially the exact same duties as the Deputy Clerk of Court staff in Clerk of Court. She said because their title is different they did not receive the reallocation, and feels this was an oversight. Ms. Timmerman said the cost is \$1,850 for the change to these two positions and the funds could come from law books, publications/dues/subscriptions, and office supplies.

Supervisor Podzilni moved to approve reallocating the Deputy Register in Probate positions from Level 4 to Level 3 using funds in the amount of \$1,850 as described above, second by Supervisor Yeomans. ADOPTED.

Ms. Gackstatter said she has a second appeal, that with the increases made to the Deputy Clerk of Court positions, there are nine of her most senior employees who would not be receiving as much of an increase due to the Personnel Ordinance 18.206 "Persons in positions reallocated shall normally be advanced to the step with the next highest dollar amount in the new pay range." Ms. Gackstatter said she feels these nine staff members should be moved to the top of the range due to their longevity instead of waiting for a year. She added that they would be receiving half the increase as the other staff with less time.

Supervisor Yeomans asked if this has happened to other employees. Ms. Mikula replied that it has, however they would not sit at that amount for the year but would move to the next step up on their anniversary date. Mr. Smith said it is hard to argue longevity of staff, but this is following the rules and they are trying to be consistent as this has implications throughout the County. Supervisor Yeomans said this is something the Blue Ribbon Committee could look at.

Supervisor Yeomans moved to deny the appeal and add a condition to refer this to Human Resources to review the Personnel Ordinance, second by Supervisor Podzilni. Request DENIED.

Other

Southern Wisconsin Regional Airport Board Mr. Cullen said the Airport Specialist position was reclassed to a Secretary II position in the budget process. He said he is asking for a change from step 2, to step 4. Mr. Cullen said he would be able to cover the \$2,547.74 difference in pay from the training and overtime accounts.

Supervisor Beaver moved to deny the appeal for the same reasons as for the Clerk of Courts denial, second by Supervisor Yeomans. Request DENIED.

Agriculture and Extension Education Committee Supervisor Bostwick said they are appealing for the Health and Wellbeing Educator position to be added back as they feel this position adds a lot of value to the populations in Rock County. Ms. Wen added that they are UW Madison employees, the fee for this position is \$42,000, the position acts as a liaison—throughout Rock County, brings UW resources to the County, leverages grant money for the counties, brings in interns at no additional cost, works with schools with apples as a healthy choice, and feel this is an investment for the County. Supervisor Aegerter said she feels this position is in line with our mission statement and that it is well known that Rock County needs help in healthier eating. She said Rock County has invested 14 years in this position and there is a need to continue these benefits.

Supervisor Bostwick said the funding could come from replacing some of the IT Departments levy with sales tax revenue (\$35,100), seasonal wages (\$1,000), travel (\$2,000) and a transfer in from the UW Extension Education Fund Balance (\$3,720).

Supervisor Beaver moved approval for this position with the above funding, second by Supervisor Podzilni. ADOPTED.

Other Supervisor Richard said the State Biennial Budget includes \$1.1 Million for Human Services to address the crisis in Child Protective Services, of which \$475,000 to be used as determined by the department. He said he is requesting \$300,000 be used to reduce the County Tax Levy.

Discussion on sales tax versus tax levy; best use of these funds; and best way to reserve the funds until we know best use of funds.

Supervisor Yeomans moved to use \$300,000 of State grant funds in the Human Services Budget be used for salaries and to reduce the tax levy, second by Supervisor Beaver. FAILED on the following vote: YES – Supervisor Beaver; NO – Supervisors Podzilni, Yeomans and Mawhinney; ABSENT – Supervisor Fox.

<u>Adjournment</u>. Supervisor Podzilni moved adjournment at 9:26 A.M., second by Supervisor Yeomans. ADOPTED.

-EXECUTIVE SUMMARY-

ACCEPTANCE OF WISCONSIN DEPARTMENT OF NATURAL RESOURCES COUNTY CONSERVATION AIDS GRANT FUNDS AND AMENDING PARKS BUDGET

Each Wisconsin County is allocated a certain amount of money annually to fund small projects on a 50/50 match basis. This year we will be using our allocated funds to help pay for invasive species control at Carver-Roehl and Magnolia Bluff Parks.

Rock County was originally allotted \$1,927 in County Conservation Aids grant funds. An additional \$1,204 in County Conservation Aids grant funds have become available, for a total award of \$3,131 for 2019. The recommended 2019 budget includes \$5,000 for this grant. This resolution accepts the \$3,131 in County Conservation Aids funds and reduces the 2019 budget from \$5,000 to \$3,131.

The invasive species control work will include burning, prairie planting, prairie restoration, mowing and invasive species removal at Carver-Roehl and Magnolia Bluff Parks. The invasive species to be controlled using this grant are Common Buckthorn, Honeysuckle, Siberian Elm, Garlic Mustard, and White/Yellow Sweet Clover. Other native but negative woody growth from Sumac, Rubus species, Elm, Boxelder, and Cherry has invaded areas of the State Natural Areas inhibiting growth of native flora and white/bur oak regeneration. These woody species will also be considered in the restoration activities

Though this funding source required a 50% match by the County, all time and materials supplied by the Parks and Highway Divisions, as well as other community resources, may be used as in-kind match.

The elimination of a Help Desk position and the addition of an additional User Support position will cost approximately \$9,500 in FY2020. The additional cost could be covered by staff vacancies or a transfer from another account if funds are available.

Executive Summary

This resolution authorizes the elimination of a Help Desk position and the addition of a User Support position in Rock County's Information Technology Department.

Information Technology has changed much over the years and no longer requires the same level of Help Desk operations and duties as in the past. Print services, job management, and backup scheduling are no longer relegated to just the Help Desk since they can be performed by online applications and sometimes by the users themselves. The reorganization of the I.T. department has afforded I.T. administration the flexibility to reclassify duties such as those of the former Help Desk to a more all-encompassing Service Desk team approach. Additionally, the I.T. department is preparing to facilitate some large-scale projects to be completed within the next few years including: major user movement within the county to 1717 Center Avenue, the elimination of all Windows 7 devices and the installation of replacement Windows 10 devices, the replacement of old, outdated computer equipment in order to standardize refresh cycles, and the move of the I.T. department out of the Health Care Center building. These projects will require increased effort and capability on the part of a user support staff that is already operating above capacity.

Given the reduction in low level Help Desk duties and the marked increase in more complex User Support activities, the addition of a User Support position will help the Information Technology department better serve both the citizens of Rock County and its workforce.

EXECUTIVE SUMMARY

Bids were solicited from qualified individuals, firms, partnerships and corporations having specific experience in paper shredding for various Rock County departments as needed. The objective of this Invitation to Bid is to enter into a one-year contract with the option to renew for two additional one-year periods, not to exceed a total of three years. The contract period will begin on January 1, 2020. Bids will remain in effect for the 2020 through 2022 calendar years.

Rock County generates approximately 82,000 – 98,000 pounds of paper to be shredded yearly.
