1. CALL TO ORDER

- 3) Note on Final CSM: "Lot 1 contains existing buildings which utilize an existing private sewage system at the time of this survey, however, soils on the lot may be restrictive to the replacement of the existing system".

- 1) Utility easement(s) shall be placed on lots as requested by utility companies (if applicable)
- 2) Note on Final CSM: "Lot 1 contains existing buildings which utilize an existing private sewage system at the time of this survey, however, soils on the lot may be restrictive to the replacement of the existing system".
- 3) Proposed lot lines shall include the POWTS area with the building that utilizes the system.
- 4) County Hwy H in this area is not access controlled, however access to the remaining south of Marsh Creek may be limited due to site distance or terrain. An access easement should be considered through Lot 1.
- 5) Final CSM shall be submitted to and approved by the Agency one year after preliminary approval.
- 6) CSM's subject to local approval shall be recorded with the Rock County Register of Deeds within 6 months of their last approval.
