MINUTES ROCK COUNTY PLANNING & DEVELOPMENT COMMITTEE THURSDAY October 10th, 2019 – 8:00 A.M. COURTHOUSE CONFERENCE ROOM Second Floor ROCK COUNTY COURTHOUSE JANESVILLE, WI

1. CALL TO ORDER

The meeting of the Rock County Planning & Development Committee was called to order at 8:00 a.m. on Thursday, October 10, 2019 at the Rock County Courthouse. Chair Sweeney presided. Supervisors present: Wes Davis, Wayne Gustina, Phil Owens and Mary Mawhinney. QUORUM PRESENT.

Rock County Staff Present: Colin Byrnes (Planning Director) Andrew Baker (Senior Planner), and Kurt Wheeler (Planner III, Acting Secretary).

2. ADOPTION OF AGENDA

Moved by Supervisor Gustina, Seconded by Supervisor Owens. Agenda Adopted (5-0).

3. <u>MEETING MINUTES – SEPTEMBER 26, 2019</u>

Motion made by Supervisor Davis, Seconded by Supervisor Owens to accept the meeting minutes. APPROVED (5-0)

4. <u>CITIZEN PARTICIPATION, COMMUNICATIONS AND ANNOUNCEMENTS</u>

Mr. Wheeler shared with the Committee that the Town of Beloit has partnered with the Planning and Development Agency to install new 911 Address signs within rural areas of the Town.

Supervisor Davis shared that there will be Rock County Regional Business Expo October 17th from 1pm to 7pm at the Holiday Inn Express in Janesville.

5. CODE ADMINISTRATION AND ENFORCEMENT

A. **Action Item:** Approve, Approve with Conditions or Deny Land Division:

• (2019 047) - Porter Township - Sayre Joint Farms

Motion to approve with Staff recommended conditions made by Supervisor Mawhinney. Seconded by Supervisor Gustina. After discussion, an amended motion was made by Supervisor Owens to determine a location, based on the original Land Division application Lot, for a replacement wastewater system area based on a soil test, and that the lot will reflect the Town of Porter's preliminary approval conditions. Seconded by Supervisor Mawhinney. Amended Motion Approved with Conditions (5-0). Main Motion as Amended Approved (5-0).

Conditions:

1. Existing utility easements shall be shown and proposed utility easements shall be placed on the lots as requested by utility companies (where applicable).

- 2. Note on Final CSM "Lot 1 contains existing buildings which, utilize an existing system at the time of this survey, however soils on the lot may be restrictive to the replacement of the existing system".
- 3. Comply with the standards in the Town of Porter Zoning Ordinance related to creating a new lot within the AE Zoning district.
- 4. An approved soil test for a Private Waste Water Treatment System (POWTS) received on Lot 1.
- 5. Final CSM shall be submitted to and approved by the Agency one year after the preliminary approval.
- 6. Final CSM's subject to local approval shall be recorded with the Rock County Register of Deeds within 6 months of their last approval.

• LD2019 049 (Beloit Township) - Town of Beloit

Motion to approve with Staff recommended conditions made by Supervisor Gustina with Conditions, Seconded by Supervisor Owens. A discussion on access points and street layout followed. Approved (5-0)

Conditions:

- 1. Existing utility easements shall be shown and proposed easements placed on the lots as requested by utility companies (where applicable).
- To assist in the consistent administration of the Rock County Address Ordinance, the address number standards found in Section 4.605 (3) shall be included on the CSM and other formal property documentation
- 3. Final CSM shall be submitted to and approved by the Agency one year after the preliminary approval.
- 4. CSM's subject to local approval shall be recorded with the Rock County Register of Deeds within 6 months of their last approval.
