Approval of the Minutes

Community Agency Updates

Immunization rates in Rock County are not good and waiver rates are high. The Health Department will be holding vaccination clinics in several locations throughout the county.

UW Extension offers parent nutrition classes.

Tonette Walker visited Human Services on July 7th. She came to formally ask us to participate in continued systems change around the Trauma Informed Care Project. The Systems Change Grant is due to come out the end of August. The grant will be about how to expand this in the community; which is what Tier 3 is about.

The Rock County Trauma Project will have a booth at National Night Out and they will be distributing information about the ACEs.

JM4C will host Youth Mental Health First Aid on August 24th and 29th. They will also have a Youth Summit on youth mental health on January 19th, at JPAC. Erin Loveland is the new JM4C Director.

The Public Health Department offers Safe Sleeping training.

Wellness & Recovery Empowerment Project (WREP) -

They are working on revising their brochure and updating their FB page. Freedom Fest was a huge success.

Review BHRSC Mission, Goals & Steps -

Tera gave an overview of how the CST/CCOP Committee reports back to the BHRSC. The BHRSC accepted our 3 goals: moving forward our system of care principles, parent support group and creating a trauma informed care taskforce. Tera will put together some ideas about measurable goals and next steps for this committee to take to move these goals forward.

- a. CST is about creating a system of care that promotes the family at the center of their plan and for families to have a voice in their plan.
- b. Liane has been trying to put together a parent support group. Parents feel it's important to have the group in the evening and they need child care. The biggest barrier is providing child care. There was a discussion around possibly trying to partner with Community Action or Head Start. They will resume efforts to create this group after school starts again.

c. We will look into partnering with The Rock County Trauma Project (courts) on projects they are working on.

Children's Community Options Program (CCOP)

We will email the CCOP Procedure Guide out to everyone for review and will discuss feedback at the August meeting.
