#### **Community Agency Updates**

Rock County Juvenile Justice was selected to be a partner with the Department of Juvenile Corrections in looking at best practices for juvenile supervision. NCCD (National Council on Crime and Delinquency) just finished their report and that should be published after the first of the year. They looked at our FFCM model and how that works with high-risk youth and their families and how the Department of Juvenile Corrections can take practices that we implemented this year in Rock County and replicate that in their after-care services for kids transitioning out of the Juvenile Correction Facility.

#### **CST Outreach Workgroup**

Outreaches were held with a police liaison group and the Optimist Club and both were well received. The next meeting will be January 12, at 9:00 a.m. in the HCC. The group will present a summary of their goals in January. Ben Dobson will be the committee chair beginning in January.

#### **Update on Parent/Youth Peer Support Development**

The group has finished their mission statement and they are currently working on core values.

### MOU update

We continue to collect signatures and we will send out a signed copy after January 1<sup>st</sup> to everyone who has signed. If more signatures are collected in the future we will send another copy out to everyone.

#### YES! Rock County update

They are still trying to start a Survivors of Suicide group. They will have a conference coming up on February 13, at Beloit Memorial Hospital.
