10.A. County Preparation for the Affordable Care Act

The report was presented by the Human Services Director, Charmian Klyve, and the Deputy Director, Phil Boutwell. A PowerPoint presentation and video were presented to explain and give the Board of Supervisors an idea what the Affordable Care Act is and how the ACA will impact the Rock County Human Services Department, especially as it pertains to the Economic Support Division.

The Patient Protection and Affordable Care Act is a Federal Law designed to increase healthcare coverage by expanding public and private insurance. In efforts to implement this law, a Federally Facilitated Marketplace has been established and open enrollment is set to begin October 1, 2013 with coverage beginning January 1, 2014. One major difference in Wisconsin is that unlike the old state guidelines for State eligibility that was based on Federal Poverty Level and family size, the Marketplace will use tax rules (MAGI) to steer applicants to public or private insurance.

It is estimated that Statewide, approximately 500,000+ individuals are currently uninsured and the ACA is an individual mandate requiring insurance. The Marketplace website can be accessed at www.healthcare.gov or at access.wi.gov. One could also call 1-800-318-2596 for assistance with the Health Insurance Marketplace.

Recently, nearly 100,000 Badger Care individuals above 100% FPL, were sent letters eliminating them from eligibility. These clients will be shifted to the Marketplace for insurance eligibility and coverage. Much has been discussed in the news lately about this, but not much has been explained about what these clients will do.

The Rock County Economic Support Division is responsible for Eligible Food Share, Medicaid and Badger Care cases and individuals contact the division via phone, walk-in, mail and internet. The ESD has been preparing so that all types of clients can be assisted and has been training so they can redirect Marketplace applicants to the "right door". It is estimated that the Marketplace system will be ready to process applications submitted between October 1 and November 17, 2013.

Key dates for enrolling in the Marketplace include: October 1, 2013 – open enrollment begins. December 15, 2013 – deadline to enroll in Marketplace for coverage to begin January 1, 2014. January 1, 2014 – Marketplace subsidized coverage begins for those between 100-400% of Federal Poverty Level. March 31, 2014 – Marketplace open enrollment ends.

While these are the known items, there are many unknowns in this unprecedented nationwide system of change to health care coverage. Wisconsin is one of 34 states that chose to utilize the federal "Marketplace" rather than a state run system. The Department of Human Services, the Southern Consortium, Rock County and other vested parties will continue to learn, improve, revise and adapt to meet the needs of our constituents and customers...but we must be patient.

To help visualize how the online Marketplace application works and what individuals will need, a video was shown and posted at http://www.youtube.com/watch?v=16KNt9Mf3GQ&safe=active. Charmian and Phil entertained questions and concerns from the Board of Supervisors before ending their report.

10.B. Rabies in Rock County-Karen Cain

Karen Cain and Tim Banwell, of the Rock County Health Department presented an overview of the Rock County Rabies/Animal Bite Program. Department Head, Karen Cain, began by reminding Supervisors that there is information about receiving annual flu shots and TDaP shots in their packet. The public can receive this information on the website at: http://www.co.rock.wi.us/public-resources

Karen reminded the Board that Rock County has had two bats in less than one month that have tested positive for rabies. While no humans were exposed, a house cat was. The worst element of contracting rabies is that it has the highest fatality rate of any conventional infectious disease and is nearly always fatal.

Statistics suggest that only five known cases in the world exist where a human survived and that includes a girl from Fond du Lac, Wisconsin in 2010. The last four Wisconsin cases of human rabies happened in 1959, 2000, 2004 and 2010 and all of them acquired the disease from infected bats. There continues to be about two deaths per years in the US from rabies; the decrease is primarily because of the rabies vaccine.

Karen asked Tim Banwell to discuss the Rabies vaccine in animals and how the Health Department deals with Animal Bites. Tim explained that there are two reasons that rabies infections have become so low; one is that animal owners are legally required to vaccinate their dogs and cats; and two, the Health Department does extensive follow up on animal bites. There are between 350-450 animal bites recorded per year that requires the assistance of veterinarians, law enforcement and animal control. When a person is bitten by an animal, they go to the clinic. The clinic contacts law enforcement, who issues an animal bite order. The bite order requires the owner to take the animal to a vet to be examined three times during a 10-day period and quarantine the animal at home if they are vaccinated. If the animal is not vaccinated, it must be quarantined at the veterinarian and can become quite costly.

In the area of bite prevention, Karen explained that most of the bites happen outside in the warmer months and are often young people. So, in response to the statistics, the Department developed a program to educate young children about approaching animals in daycares around the community. This program teaches children how to approach a dog and prevent provoking a bite. This program has been quite successful.

It is estimated that of the roughly 400 animal bites that happen in Rock County each year, up to half of them are not vaccinated. Tim estimated that there are 40,000 pets in Rock County and if half are not vaccinated, that creates a need to persuade and influence owners to understand the risk and liability of having unvaccinated pets. In response to this concern, there have been two very successful Rabies vaccination clinics in recent months where animal owners could vaccinate their dogs for \$10 thanks to the assistance from Friends of Noah, many local veterinarians, volunteers and the vaccine vendor, Merck Pharmaceuticals. These clinics have vaccinated over 1,000 animals this year. There will be another one next April at the Rock County Fairgrounds and details on that clinic will be forthcoming.

Tim and Karen entertained questions from the Board before ending their report.
