#### <u>Placing a Referendum on the Spring 2022 Ballot on Whether Rock County Should Issue</u> <u>\$96 Million Dollars in New Debt to Build a New Facility and Jail for the Rock County</u> Sheriff's Office

"NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 20\_\_\_ does hereby direct the Rock County Clerk to place the following advisory referendum on the April 5, 2022:

"Should Rock County construct a new Law Enforcement Services Facility and County Jail, replacing the current facilities, at an estimated borrowing and interest cost in property taxes of \$116 million?""

Supervisor Bostwick moved approval of the above resolution, second by Supervisor Rynes.

Supervisor Rynes asked about the status of building a new facility and jail for the Rock County Sheriff's Office. Brent reminded the committee of the space needs and conditions assessments that happened in 2020. He reminded the committee that additional funding was approved by County Board to do the project in one complete phase (Resolution 21-5B-265 - Retaining Venture Architects for Architectural and Engineering Services for Sheriff's Office Law Enforcement Services/Jail Renovation Project and Amending the Facilities Management 2021 Capital Budget). Brent stated that they have already completed design piece.

Sheriff Knudson highlighted the history of the building renovation. He passed around pictures of some conditions of the building. Sheriff Knudson advocated for the need for this project to move forward.

Supervisor Richard advocated for the education of Rock County citizens of this project. He pointed to the potential increase in property taxes.
