

## PUBLIC SAFETY & JUSTICE COMMITTEE Minutes – August 7, 2017

<u>Call to Order</u>. Chair Beaver called the meeting of the Public Safety and Justice Committee to order at 4:00 P.M. on August 7, 2017 in Conference Room N-1, Fifth Floor, Courthouse East.

<u>Adoption of Agenda</u>. Supervisor Knudson moved approval of the agenda as presented, second by Supervisor Fell. ADOPTED.

Citizen Participation, Communications, Announcement, Information. Mr. Farrell handed out copies, which he is sending to the media, regarding September being Suicide Prevention Awareness Month. He said there have been 25 tragedies this year, none of them were twelfth grade and under. He added that the schools have very strong campaigns on suicide as well as drug and alcohol abuse, the wearing of seat belts, and texting and driving. Mr. Farrell thanked, in particular, the Rock County 911 Communications Center, Rock County First Responders (Law Enforcement, Fire Protection and Paramedics/EMS), Rock County Crisis Intervention Services, and Rock County Schools, Youth Groups and Media.
