2, was	Medical Examiner Department Update. A corrected update memo, which included page distributed to the Committee.
Medica Intergo varianc	Mr. Irmen said the partnership with Dane County in 2015 brought a Forensic Pathologist all Examiner for Rock County, using best practices, instead of a lay person. He said the vernmental Agreement (IGA) allowed 75-95 autopsies without having to reconcile the se and 128 autopsies were conducted in 2015. Rock County was invoiced for the additional opsies at approximately \$65,000, which was primarily covered by savings in staff costs in
	Mr. Irmen said based on the first six months of 2016, there have been 70 autopsies and five

external examinations, he is projecting 140 autopsies and 11 external exams. 140 autopsies would result in an additional \$68,646 inclusive of transportation costs. The doctors have cleared 426 cases and he is projecting a total of 841. Based on these projections it looks like the ME's Office will be about \$60,000 - \$70,000 over budget. Mr. Irmen will return to the Committee at year end to provide a more definite budget adjustment request.

Supervisor Knudson thanked Mr. Irmen and the rest of the Medical Examiner's Office for the level of professionalism they have provided Rock County citizens.

Mr. Terronez said when Rock County entered into the IGA there were a number of meetings with funeral homes and law enforcement and we will be having these meetings again as we discuss renewing the IGA with Dane County.

<u>Semi-Annual Reports.</u> The Committee accepted the reports.

<u>Committee Requests and Motions.</u> Supervisor Knudson said the Sheriff's Office did a very nice job at the Rock County 4-H Fair.

<u>Adjournment</u>. Supervisor Owens moved adjournment at 4:14 P.M., second by Supervisor Fell. ADOPTED.
