Updates.

911 Communications Center Annual Report Ms. Sukus handed out copies of the Rock County Communications 2017 Annual Report and went over the highlights. She said the activity level stayed about the same from the prior year, their answer time is at about 95% in the 10 seconds or less range, and they have done presentations for all the school districts.

Supervisor Fell congratulated Ms. Sukus and the 911 team on a great job and for keeping on top of things. He mentioned the news report on TV regarding the life one of the dispatchers had saved.

Upgrade to Audio and Video Conference System for the Courts Mr. Terronez said there is \$450,000 budgeted for the audio and video conferencing upgrades for the courts. These upgrades are for the arraignments done for youth, mentally challenged inmates, and will help cut down on transporting inmates to Rock County and back to whichever facility they are being housed. Mr. Terronez added this upgrade will help Judges, law enforcement, the District Attorney, defense attorneys, etc. He said the resolution will be going to the Finance Committee and then on to the County Board.

<u>Committee Requests and Motions.</u> Chair Beaver said the Committee will be touring the Emergency Operations Center and the Sheriff's Office and Jail at future meetings.
