- The Presentation of the Recommended Budget will be done on October 14, 2010 County Board Meeting. The DD Board has not been asked to make any changes/revisions since our last meeting and submission on September 23, 2010.
- We have been continuing to work with the State DHS on the relocation of three individuals back into community settings. At this time, we cannot project when this might occur.
- We have also had meetings with Catholic Charities and DHS regarding developing a residential program that might be able to serve three children that are currently under the CLTW.
- Ms. Kane is on vacation this week and will return on Monday, October 18th.
- "Together We Serve" had their 3rd Annual Fish Fry last Friday, October 8th.
- The ADRC "work group" and the Steering Committee met last Wednesday, October 6th to discuss I & A Workers and Benefit Specialist roles. The next full meeting for the Steering Committee will be Wednesday, November 3rd at 3pm, to discuss access to Services. On this same date, the Public Hearing on the 2011 Proposed County Budget will be at 6pm. December meetings will discuss Staffing patterns and Governing Board.
- We had a consumer pass away this past Saturday who resided in Rock Haven. She was 64 yrs old.
