Supervisor Wiedenfeld moved approval of the above Transfers and Appropriations, Bills and Encumbrances and Pre-Approved Encumbrance Amendments for the Public Safety & Justice Committee with the changes (*) to the 2016 Encumbrances for the Sheriff's Office, second by Supervisor Knudson. ADOPTED.

Report on Dual Reporting of Child Abuse & Neglect – 2015 Senate Bill 326. Mr.

O'Leary went over the highlights of the letter from the Attorney General. He said there is a great deal of support for this Bill at the state level. He said there may be cases that both law enforcement and CPS may be working on and they may not know about it. This would help reduce a duplication of effort and help create a safer environment for the child. He said the primary goal of SB326 is to help ensure the safety of the child by sharing information. He explained this is one of the goals of the Criminal Justice Coordinating Council (CJCC), to share resources and to help make the system work better. He suggested letting the CJCC discuss how best to share and handle this.

Mr. O'Leary added that most law enforcement support SB326, as does the Attorney General. That there should be a way for everyone to work together and that this is to protect the children, which he feels is a number one priority.

Supervisor Wiedenfeld asked when the Bill would be acted on. Mr. O'Leary said he did not know but felt it would be early in the session and would let Administration know as soon as he hears anything. He added that it is not yet known what the fiscal impact of the Bill will be.

Mr. O'Leary apologized to the Committee for not coming before them sooner.

Supervisor Fell said he thought the Wisconsin Counties Association (WCA) just wanted to fine tune the language of the Bill. Supervisor Podzilni said that is correct.

Mr. O'Leary said he would touch base with the WCA and keep the Committee posted.

Supervisor Knudson asked Mr. O'Leary if he would be able to attend the next Human Services Board meeting on January 13, 2016 at 4:30 P.M. Mr. O'Leary said he would put it on his calendar.

Supervisor Kraft said she felt someone from the Sheriff's Office should give an opinion. She said she would see about putting it on the January CJCC agenda and have all three departments there to discuss.

Committee Requests and Motions. None.

<u>Adjournment</u>. Supervisor Wiedenfeld moved adjournment at 4:31 P.M., second by Supervisor Fell. ADOPTED.
