**2013 Annual Jail Report.** Captain Strouse said he is happy with the report; everything is at or near best practice.

Supervisor Brill asked about the mention of mattresses on the floor. Captain Strouse said nobody is sleeping on the floor, the Huber dorm had mattresses stacked on the floor in case they were needed.

Supervisor Brill asked about the undersized kitchen, laundry, storage, etc. Captain Strouse said they have been running at about 400 inmates, with 377 for meals, and they are approved for a maximum of 505 beds. So with these numbers they are doing fine.

Chair Collins said he felt, overall, the report was good and he and the Committee would like to commend the Jail staff.

Status of the Coroner's Office, Current Mission Objectives and Community Programs. Mr. Smit said their objective has been to continue as they had when Ms. Keach was still Coroner; and they just graduated their first academy. He introduced: Mr. Jack Friess, Deputy Coroner/Analyst, who has been working on the 1995 John Doe cold case from Clinton; Tony Farrell Sr., volunteer Deputy Coroner, who has worked extensively on suicide prevention; and two new deputy coroner's Erin Berryman and Jody Paul, who just started today.

Supervisor Brill asked about the cooler in the old Rock Haven. Mr. Smit said they have been using it. Further discussion ensued.

Supervisor Knudson complimented Mr. Smit and staff.

<u>Committee Requests and Motions.</u> Chair Collins congratulated Captain Strouse on his upcoming 20<sup>th</sup> anniversary with Rock County.

<u>Adjournment</u>. Supervisor Knudson moved adjournment at 4:35 P.M., second by Supervisor Wiedenfeld. ADOPTED.
