Notice is hereby given that the Rock County Board of Adjustment will hear a request for a variance of the Rock County Shoreland Overlay Zoning Ordinance Section 4.205 related to minimum lot size in a sewered area and setback requirements. The property owner/applicant (Keith Kapa) is requesting a variance to combine two existing nonconforming lots. The total area of the two lots does not meet the required minimum lot area. A variance from minimum front and/or rear setback requirements is also requested. The purpose of this project is to build a new house.
