Department Reports.

<u>"Lighten Up" Research Project – Joyce Lubben.</u> Ms. Lubben stated the Council on Aging Department would be partnering in this evidenced-based project with Brown and Kenosha Counties. This is an eight-week workshop and is grant funded. There will be a three-day training in Kenosha County. Ms. Lubben stated this project is a group-based wellness program for older adults to improve mental health and well being by using positive journaling.

<u>Semi-Annual Report – Attendance at Conventions/Conferences.</u>

<u>Council on Aging</u> Ms. Lubben stated there was only the November Conference trip to San Diego for a total cost of \$1,730.22. These costs were totally paid for through the federal Nutrition Program grant.

<u>Veterans Service Office</u> Mr. Solis stated his department did not attend any conventions/conferences in excess of \$1,000.00.

<u>Discussion on Future Meeting Site Visits.</u> Chair Thomas informed the Committee that a representative from Blackhawk Technical College would attend the February meeting here at the Courthouse.

<u>Ideas for Future Discussion</u> Mr. Solis said this year is the 50th anniversary of the Vietnam War. Mr. Solis will work on a resolution for Chair Thomas to review. Supervisor Nash mentioned the war memorial statue on the corner of Milwaukee and Franklin Street and asked if the Committee could promote the moving of this statue to the Veterans Park located within Traxler Park. Mr. Solis said the City of Janesville is in charge of this and he remembered that this was brought up in the past and it was cost prohibitive to move the statue.
