BE IT FURTHER RESOLVED, that proceeds from the sale of County owned real estate holdings, with the exception of park land and IN REM properties, will be deposited into the PACE account to assure that the short and long term goals of the program are met. If proceeds from said sales are available they should not be used to reduce the annual budget appropriation requested.

Supervisors Bostwick and Sweeney moved the above resolution. After some discussion Supervisors Sweeney and Dowd moved to amend the resolution by striking the words "and the tax levy" from line 30 of the resolution. Amendment ADOPTED by acclamation.

Supervisors Mawhinney and Kraft moved a second amendment to change the funds allocation in the resolution from \$200,000 to \$100,000 taken from sales tax proceeds, and change that resolution to reflect that the financial commitment to be for one year. She explained that the reservation on this resolution is not about preserving farmland in Rock County. Rather, she shared concerns that allocating sales tax revenues for continuing programs is a slippery slope and not the intended purpose for the .5% county sales tax. She reminded the Board that the original intent was to use sales tax revenues for Capital Projects and this is not. Supervisor Mawhinney indicated that if the funding were coming from another source, she could support it.

The current ordinance, because of a confusing format and changes in the Wisconsin Statutes it was based upon, became unenforceable. The proposed ordinance preserves the intent of the former ordinance but in a format that provides for clarity and ease of reporting. It is not necessary to spell out each permutation of the statutes nor the definitions therein since by publication thereof, each person is conclusively presumed to know what the proscribed activity is.

Variations in the format make this ordinance difficult, if not impossible. Enactment of the ordinance will not change the intent or substance of any existing ordinance but will, over time, bring more clarity to the Rock County Code of Ordinances.
