To date, there have been 7 suicides in Rock County for 2014. Mr. Farrell, Sr. explained that in 2013 they documented 42 "saves" from having people in place to help those in crisis.

10.A. ADRC Operations-Jennifer Thompson

The report on the Aging and Disability Resource Center of Rock County (one year after opening) was presented by Jennifer Thompson, LTS/ADRC Division Manager. Ms. Thompson explained that the facility is its separate location and includes ADRS only parking. They worked to make the facility welcoming and accessible. There are private meeting rooms to meet with clients and the ADRC is co-located in the Job Center with Economic Support and Long Term Support, services often inquired about and/or utilized by clients.

There are 13 staff members at the ADRC: 1 manager, 1 supervisor, 8 information and assistance specialists, and 2 disability benefits specialists. All the Long Term Care assistance needs come through the ADRC where they provide information on services, counseling options, a long term care functional screening, public funding/waiting lists, and elder/adults at risk referrals.

Disability Benefit Specialists work with people ages 18-59 and help them sort through issues regarding financial benefits such as public funding, Medicare, Medicaid, food share and Badgercare. They also help people identify what they are eligible for, assist them in application and provide assistance for SSI and SSD-I appeals.

In the first year of operation there were 6,646 contacts. Jennifer provided a chart that broke down the contacts by type of call, ages of clients and whether they were for mental health, Developmentally disabled, physically disabled or elderly. Public benefits were 3,224 of the 6,646 contacts for services; followed by 1,425 contacts for In Homes Services and 1,182 contacts pertaining to Housing.

New in 2014 is a Dementia Care Specialist that will start in June thanks to a \$80,000 grant that funds the position for one year. The ADRC is contracting with The Alzheimer's & Dementia Alliance and will form other partnerships within the community.

The ADRC has completed a webpage for those who can access the internet. This page explains the services offered at the ADRC and allows access to a resource database. There is a calendar of events and also has powerful links to helpful sites and contact information. The ADRC operates Monday – Friday from 8:00am to 4:30pm.

**Section 1.** Rock County shall join with other Wisconsin municipalities in accordance with the Intergovernmental Cooperation Act by becoming a participant of the Fund and adopting and entering into the Intergovernmental Cooperation Agreement. A copy of the Intergovernmental Cooperation Agreement shall be filed in the minutes of the meeting at which this Resolution was adopted. The County Board Chair and the County Clerk are authorized to take such actions and execute any and all such documents as they may deem necessary and appropriate to effectuate the entry of Rock County into the Intergovernmental Cooperation Agreement and to utilize Fund

programs through PMA Financial Network, Inc., PMA Securities, Inc. U. S. Bank National Association, and/or their affiliates and successors.

**Section 2.** Rock County is authorized to invest its available monies from time to time and to withdraw such monies from time to time in accordance with the provisions of the Intergovernmental Cooperation Agreement, including investment in the fixed-income program of the Fund through the intermediaries PMA Financial Network, Inc. and PMA Securities, Inc. The following officers and officials of Rock County and their respective successors in office each are designated as "Authorized Officials" with full power and authority to effectuate the investment and withdrawal of monies of Rock County from time to time in accordance with the Intergovernmental Cooperation Agreement and pursuant to the Fixed Rate Investment Program available to participants of the Fund:

Name: Vicki Brown Position: County Treasurer Signature: The County Clerk shall advise the Commission of any changes in Authorized Officials in accordance with procedures established by the Commission.

**Section 3.** Members of the Rock County Board of Supervisors and officials of Rock County are authorized to serve as Commissioners of the Commission from time to time if selected as such pursuant to the provisions of the Intergovernmental Cooperation Agreement.

**Section 4.** Rock County may open depository accounts, enter into wire transfer agreements, safekeeping agreements, and lockbox agreements, or other applicable or related documents with U. S. Bank National Association, and any other institutions participating in the Fund programs or programs of PMA Financial Network, Inc. and PMA Securities, Inc., pursuant to Wisconsin Statutes, Section 34.05, Wisconsin Statutes, Section 120.12(7) (if applicable) and, when directed by one of the Authorized Officials, Wisconsin Statutes, Section 66.0603. PMA Financial Network, Inc. and/or PMA Securities, Inc. are authorized to act on behalf of Rock County as its agent with respect to such accounts and agreements.

**Section 5.** Credit unions, banks, savings banks, trust companies and savings and loan associations authorized to transact business in the State of Wisconsin which qualify as depositories under Wisconsin law and are included on a list approved and maintained for such purpose by the Administrator of the Fund are designated as depositories of Rock County pursuant to Wisconsin Statutes, Section 120.12(7) (if applicable) and Wisconsin Statutes, Section 34.05. Monies of Rock County may be deposited in such depositories, from time to time in the discretion of the Authorized Officials, pursuant to the Fixed Rate Investment Program available to participants of the Fund through the intermediary PMA Financial Network, Inc.
