#### **Resolution**

## Designating Rock County to be a Recovery Zone for Purposes of the American Recovery and Reinvestment Act of 2009

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this \_\_\_\_\_ day of \_\_\_\_\_, 2010, that:

Section 1. Existence of Recovery Zone Conditions in County. There exist conditions including significant poverty, unemployment, rate of foreclosures and general economic distress which cause the County as a whole to be subject to designation as a recovery zone under the American Recovery and Reinvestment Act of 2009.

<u>Section 2. Designation of Recovery Zone.</u> All of the territory located within the boundaries of the County is hereby designated as a recovery zone for all purposes of and as provided in the Recovery Act.

<u>Section 3. General Authorization.</u> The officers of the County are authorized and directed to take all actions necessary or convenient in connection with the designation of the County as a recovery zone and the issuance of Recovery Zone Bonds by the County or by other eligible issuers within the County."

Supervisor Kraft moved approval of the above resolution, second by Supervisor Beaver.

Mr. Smith handed out the Executive Summary and some information on the American Recovery & Reinvestment Act of 2009 (ARRA). He said this resolution does not commit the County to issue debt under these new types of tax-preferred bonds, but only designates the county as a Recovery Zone, which makes it eligible to issue debt or allocate the authority to an eligible municipality within the county. ADOPTED.

<u>Semi-Annual Departmental Out of State Training and Conference Report</u> – <u>Information Technology.</u> Mr. Crittenden went over the report. The Committee accepted the report from Information Technology and directed it be placed on file.

**Discussion on Possible Audit of the County's AT&T Telecommunications Billing** Mr. Crittenden said this was last done in 2003 and, with the 50/50 split, the County recovered about \$19,000. The records are now computerized which will make this program much easier, faster and take less employee time. The Committee was in favor of doing this again and gave Mr. Crittenden the go ahead to write a resolution.

<u>**Report on Cash Balances and Investments – Finance Director.</u>** Mr. Smith updated the Committee on cash balances and investments as of December 31, 2009.</u>

<u>Adjournment</u>. Supervisor Podzilni moved adjournment at 8:38 A.M., second by Supervisor Beaver. ADOPTED.
