#### Resolution to Designate Elder Adult-at-Risk and Adult-at-Risk Agencies

**"NOW, THEREFORE, BE IT RESOLVED** that the Rock County Board of Supervisors duly assembled this \_\_\_\_\_ day of \_\_\_\_\_, 2009, does hereby designate Rock County Human Services as Rock County's lead "Elder Adult-at-Risk Agency" for elders pursuant to Chapter 46 of the Wisconsin Statutes, and Rock County Human Services as Rock County's "Adult-at-Risk Agency" pursuant to Chapter 55 of the Wisconsin Statutes.

**BE IT FURTHER RESOLVED** that the duties of these agencies are as described above.

**BE IT FURTHER RESOLVED** that this designation shall be effective January 1, 2010."

Supervisor Wopat moved approval of the above resolution, second by Supervisor Gustina. ADOPTED.

## Public Hearing.

**2010** Specialized Transportation Assistance Grant Application. Chair Wiedenfeld opened the Public Hearing at 4:15 P.M. Ms. Lubben distributed the application. She said this grant funds the Specialized Transit Program and the Volunteer Driver Program. She advised the Committee does not have to approve this application, it was adopted with the 2010 Budget. Chair Wiedenfeld closed the Public Hearing at 4:22 P.M.

<u>Continuing Discussion on Youth in Government Program.</u> Ms. Fredrich said she talked with three teachers last spring about the government program. They thought it was a good program but said they would not introduce it to schools in the spring. They suggested it be done the end of September or early October. Ms. Fredrich said she has the application form and information for all of the schools but she has not contacted them yet. She will make the contacts and report back to the Committee at the December 15<sup>th</sup> meeting.

Chair Wiedenfeld advised students and their Social Studies teacher will be attending the November 19<sup>th</sup> County Board meeting to witness the passage of the resolution, "Designating CTH G as Martin Luther King Jr. Memorial Highway".

<u>Committee Requests and Motions</u>. Supervisor Wopat told the Committee about the annual G.M. food drive which he used to run. They were able to serve about 350 families. He reflected on the generosity of everyone involved and what a wonderful feeling everyone got by helping others. He commented on how the closing of the plant will affect the ability to collect and provide this food for these families. He is working on a number of ways to help those in need.

Dean Pillard said the Campus has a similar program for Christmas. She said there are many people returning to college to better their lives but are having a difficult time financially. She cited single parents in particular.

Dean Pillard said there are 1,156 students currently enrolled. She thanked the County for the lovely facility which is serving them very well. She commented they would not have been able to accept this number of students had the expansion not been done.

<u>Adjournment.</u> Supervisor Gustina moved adjournment at 4:57 P.M., second by Supervisor Thomas. ADOPTED.
