  - a) Acting Rock County IT Director Dara Mosley was appointed as Interim IT Director.
  - b) Status screens IT has completed the CAD status screens through PremierOne reporting. Law agencies now can see a summary of where/what Fire/EMS units are doing and vice versa. No details of the incident can be seen.
  - c) 2019 budget information P1Mobile & NetMotion recently emailed out to all agencies.
  - d) All vehicles have been updated to the new CAD upgrade.

### a) Backup frequencies & Fire Paging Status

- Backup frequencies Waiting on two agencies to have programming done, but other agencies can use frequencies.
- Paging Went live yesterday, July 17, 2018.

### b) 2019 Goals/Objectives

- MASTR III radio system controllers replaced RF Central Rptr & County Tac Rptr channels first. Also budgeted for simulcast on those frequencies to improve coverage. Antenna for this system would also help coverage on RF Main & County Main channels.
- FirstNet Budgeted for a device and diagnostic software so IT can see how coverage is in each area of the county and report that information back to agencies.
- Pictometry Last flyover was 2015. Was cut from budget last year.
- Develop High School liaison internships.
- Create a peer support group for dispatch.

# c) <u>Priority incident (MARS) training</u> Brian Becker had a training Monday, July 16<sup>th</sup> and another one is scheduled for Thursday, July 19<sup>th</sup>.

## d) OEC - RFI for WISCOM & 911 ESInet

The Office of Emergency Communications has sent out Request for Information to vendors to develop an RFP for WISCOM the state's radio system. Once they have that information the state will request funds in the next budget as there are no funds for the system budgeted.

An RFI was also sent out for the 911 ESInet (Emergency Services IP Network-for 911 communications services) so that system can be bid out as well. Sukus will update agencies on both projects and forward emails she receives so agencies can be kept in the loop.
