Consideration and Approval of Worker's Compensation Excess Coverage Renewal. Mr. Kuglitsch advised our insurance consultant is recommending we stay with Safety National. There is a modest increase over the 2009 premium. He said we will also be switching the term of the coverage to get on a calendar year basis.

Supervisor Kraft moved approval of continuing the Worker's Compensation Excess Coverage with Safety National, second by Supervisor Diestler. ADOPTED.

The Committee took a break from 8:22 A.M. to 8:27 A.M.

Review of 2010 Debt Issue – Carol Wirth, President, Wisconsin Public Finance Professionals, LLC. Ms. Wirth passed out copies of her report and said this is the structure and plan on how to finance the 2010 Bond Issue. Page 1 lists the 2009 and 2010 Capital Projects. The authority is already in place when the County Board adopted the Initial Borrowing Resolutions. The resolutions authorizing debt issues are valid for a five-year period. If they are approved by a ¾ vote of the entire Board, the debt service is exempt from the State imposed debt tax rate limits.

Ms. Wirth said the budgeted amount for 2009/2010 Capital Projects is \$5,721,946, borrowing fees are \$93,054, for a total of \$5,815,000. She reviewed Rock County's Existing Debt Service Schedule.

Ms. Wirth reminded the Committee of her presentation on February 4<sup>th</sup>. At that time she explained the borrowing options – Build America Bonds (BABs), no allocation required; and Recovery Zone Economic Development Bonds (Super BABs), require an allocation but the County can apply for a federal interest subsidy of 45%. Rock County applied for and received an allocation of \$10,034,000, \$4,635,00 of which was reallocated to the City of Beloit. At the February 4<sup>th</sup> meeting, the Committee was in favor of the Super BABs option.

Ms. Wirth advised the County must file a claim every six months to get the subsidy and the federal government will be monitoring these programs closely. If you are out of compliance, you will lose the subsidy. She went through a timetable of events, with June 15 the date for delivery of funds. Mr. Smith said a draft resolution will be provided to the Finance Committee at the May 20<sup>th</sup> meeting.

Report on Cash Balances and Investments. Mr. Smith updated the Committee on cash balances and investments as of March 31, 2010.

<u>Adjournment</u>. Supervisor Diestler moved adjournment at 9:20 A.M., second by Supervisor Beaver. ADOPTED.
