FINANCE COMMITTEE August 18, 2011

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, August 18, 2011, in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Committee Members Present</u>. Supervisors Mawhinney, Kraft, Podzilni, Beaver and Diestler.

Committee Members Excused: None.

<u>Staff Members Present</u>. <u>Approval of Agenda</u>. Chair Mawhinney said there was an additional transfer for Council on Aging. Supervisor Podzilni moved approval of the agenda with this addition, second by Supervisor Diestler. ADOPTED.

Approval of Minutes. Mr. Smith asked to have the following replace the second to last sentence of the first paragraph on page 3: "In accordance with Wisconsin Statutes, total general obligation indebtedness of the county may not exceed 5% of the equalized value of taxable property within the county's jurisdiction. The debt limit as of December 31, 2010, was \$504,972,660. Total general obligation debt outstanding at year end was \$16,040,000 which is 3.13% of the debt limit which is very positive." Supervisor Kraft moved approval of the minutes of August 4, 2011 with this change, second by Supervisor Diestler. ADOPTED.

<u>Citizen Participation, Communications, Announcements, Information.</u> Supervisor Podzilni said the next Redistricting Committee meeting will be August 29th at 2:00 P.M. in the Courthouse Conference Center.

Supervisor Podzilni said Business After 5 was being held at Kutter Harley Davidson on Thursday.

Review of 2011 \$4.5 Million Capital Improvement Debt Issue - Carol Wirth, President, Wisconsin Public Finance Professionals, LLC. Ms. Wirth handed out her Report on Financing - 2011 Capital Projects with \$4,500,000 Tax-Exempt General Obligation Promissory Notes - 2011A. She went over the capital projects the County Board approved for the 2011 General Obligation Note funding and the issuance expense list. Ms. Wirth said the Estimated Debt Service is based on the interest rates last week and interest will be paid twice per year, with the last two years being callable. Ms. Wirth went over the estimated pricing schedule

and said the net interest cost is 2.37%. She went over the list of debt issues currently outstanding through 2015, the debt issue with the new issue of \$4.5 million, and all General Obligation Debt through 2020.

Ms. Wirth said the funds are to be used within the 2-year term.

Mr. Smith said that the Rock Haven Project may qualify for Qualified Energy Conservation Bonds with a 75% federal interest rebate.

Supervisor Diestler asked what the schedule was for Rock Haven. Mr. Knutson said the bids are due August 24th and there will be a joint General Services / Health Services meeting on August 30th. The resolutions will then go on to the County Board September 8th.

Chair Mawhinney asked Ms. Wirth if the County needed to borrow more would we need to go to Moody's and S&P with Ms. Wirth replying we would.
