FINANCE COMMITTEE March 3, 2011

<u>Call to Order</u>. Vice Chair Kraft called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, March 3, 2011, in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Approval of Agenda</u>. Mr. Smith said there was a Pre-Approved Encumbrance Amendment for General Services to be added under 6.D. Supervisor Podzilni moved approval of the agenda with this addition, second by Supervisor Diestler. ADOPTED as amended.

Mr. Smith said he would be coming in for a transfer request to cover these costs.

Mr. Smith said he attached the current Statement of Investment Policy and said that the Finance Committee is supposed to review this. He asked the committee to let him know in advance of the next meeting any chances they might like to make to this policy.
