# FINANCE COMMITTEE Minutes – April 3, 2014

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, April 3, 2014, in Conference Room N-1 Rock County Courthouse East.

Committee Members Present. Supervisors Mawhinney, Kraft, Fox and Podzilni.

<u>Approval of Agenda</u>. Supervisor Fox moved approval of the agenda, second by Supervisor Podzilni. ADOPTED.

<u>Citizen Participation, Communications and Announcements.</u> Chair Mawhinney asked everyone to keep Supervisor Beaver in their thoughts today.

Mr. Knutson asked the Committee to start thinking about pre-budget meetings.

<u>Approval of Minutes - March 20, 2014.</u> Supervisor Podzilni moved approval of the minutes of March 20, 2014 as presented, second by Supervisor Kraft. ADOPTED.

Report by Cutwater Asset Management. Mr. Witthohn said interest rates are still low, but are expected to rise in about 1 ½ to 2 years. Therefore, we need to shorten up the length of our portfolio so that we have funds to invest when rates start to go up. It may mean a little lower return for a while, but it will be a smarter move overall. He said inflation is just over 1% and he would like to see it closer to 2%. Inflation helps move the economy forward. He said if the inflation rate doesn't increase soon it will take the economy longer to grow. He said our bank ratings list looks good and expressed caution on two of the banks. He suggested watching the bank ratings trend each quarter.

Ms. Brown asked Mr. Witthohn his thoughts about putting deposit funds in an Insured Cash Sweep (ICS) account and asked what his position is on this. Mr. Witthohn said he feels it is okay as they are similar to CDARS (certificates of deposit), they are FDIC insured and would diversify our assets. He suggested starting out with 10%-15% of our cash to begin with and that it is a reasonable investment pool. He suggested testing out the ease of use before putting too much in. Ms. Brown asked about PMA. Mr. Witthohn said they have a good reputation.

Committee Review and Approval of Per Meeting Allowances. Supervisor Podzilni moved approval of per meeting allowances in the amount of \$11,005.36, second by Supervisor Kraft.
