Discussion: Hiring process for Mobility Manager Position

Chair Svingen announced his resignation of the position of Mobility Manager of Rock County effective at the end of August. Member Lubben provided an overview of the hiring process to fill the position of Mobility Manager for Rock County. Maintaining the vision and momentum of the TCC and the Coordinated Plan was deemed central to continued improvements to the transportation system in Rock County.

Discussion: TCC approach to Mobility Manager Transition

The TCC will continue with its current meeting format with full meetings every other month and subcommittee meetings held in the off months. Vice Chair Nolan will lead full TCC meetings until a new chair is elected according to the Committee Bylaws.

Discussion: 4-H Fair recap

Overall the 4-H fair booth lacked the traffic to justify the amount of staff time needed to participate in the event. The booth also lacked a draw that enticed visitors. The Committee agreed that focusing attention on other events where the TCC can have a greater impact is a better use of time and money. The Committee will compile a list of area events during the next scheduled meeting (9/12).

Member Skelly moved to purchase a table cover and stand up sign reflecting the TCC and its role in the community. Member Schomber seconded the motion. Motion passed unanimously.
