<u>Discussion / Possible Action on Change to Responsible Bidder Determination.</u> Mr. Kuglitsch said Mr. Leu suggested a bidding requirement be changed to include that if a bidder wished to be considered for a contract, in this case the Jail roof, they will have had at least one project of at least 50% of size, or value of project being bid on. He added that Dane County and the State of Wisconsin have similar provisions they use on some of their larger projects. He said his concern was that Rock County has not done this before. He asked the Committee if they wished to do this on a case by case determination.

Supervisor Podzilni moved to have a requirement for the bidder to have completed at least one project of at least 50% of size, or value of project being bid, second by Supervisor Kraft.

Discussion on having a bid bond and the issues of collection mid-project.

Ms. Oja and Mr. Knutson asked if was to go to both Committees for approval on a case by case basis. Mr. Knutson added that this should not delay the project.

Supervisor Podzilni amended his motion to include the new requirement should go to both Committees and be approved on a case by case basis, second by Supervisor Kraft.

Chair Mawhinney said as long as this will not exclude local bidders from the process.

ADOPTED.
