Mr. Knutson went over the settlement, parking lot, which met with City of Janesville requirements, and seller responsibilities. Mr. Knutson said the sellers are putting \$10,000 in for any repairs. The conditional report came back good with no major problems. He said he recommends approval with funding through deferred financing. Mr. Knutson added that there is the possibility of using sales tax money. Rent will continue to be charged to the Job Center partners and this will partially recoup the purchase price.
