FINANCE COMMITTEE April 5, 2012

<u>Call to Order</u>. Chair Mawhinney called the meeting of the Finance Committee to order at 7:30 A.M. on Thursday, April 5, 2012, in Conference Room N-1 Rock County Courthouse East.

<u>Approval of Agenda</u>. Supervisor Podzilni moved approval of the amended agenda as presented, second by Supervisor Beaver. ADOPTED.

<u>Committee Review and Approval of Per Meeting Allowances.</u> Supervisor Kraft moved approval of per meeting allowances in the amount of \$13,810.63, second by Supervisor Podzilni. ADOPTED.

<u>Approval of Minutes – March 1, 2012, March 15, 2012 and March 22, 2012.</u> Supervisor Beaver moved approval of the minutes of March 1, 2012, March 15, 2012 and March 22, 2012 minutes as presented, second by Supervisor Podzilni. ADOPTED.

<u>Citizen Participation, Communications, Announcements, Information.</u> Ms. Brown said they had been at 400 parcels owing 2008 taxes and they are now at 270 parcels, with 130 of them in subdivisions.

Ms. Oja said the sales tax collections through February were good, but it slowed down in March. Rock County is still ahead of last year overall.

Supervisor Kraft said at the Board of Health meeting the prior evening the use of credit card machines at immunizations clinics was discussed and asked if this was in the budget, to which Mr. Knutson said they did budget for credit card fees. She also asked if there was a way for the County not to pay these fees. Ms. Strombeck and Ms. Miller explained that it is illegal to pass the fee on to the customer, but if a processor was used they could do this. Mr. Crittenden said he felt it would put the County at risk to store any credit card numbers and information. Ms. Strombeck offered to pass information regarding the representative the other municipalities use on to the County.

<u>Discussion and Possible Action on Bank Contract Renewal</u> Ms. Brown said we are at the end of a 3-year contract with First National Bank and Trust Company and the Committee needed to make a decision if they wished to renew the contract.

Ms. Strombeck said First National Bank and Trust has two options for the County on interest. 1) The rate for excess funds would earn the Daily Federal Funds rate minus .25% and the collateral requirements would remain with US Government issued securities with a fixed rate of .45%; or 2) the County would have a one-year Federal Home Loan Bank Letter of Credit with a fixed rate of .65%.

Supervisor Podzilni moved to table the issue of the investment policy to the April 19th meeting, second by Supervisor Beaver. TABLED to April 19, 2012.

Supervisor Kraft moved to remain with First National Bank and Trust Company, second by Supervisor Podzilni. ADOPTED.

<u>Collections</u> Ms. Brown handed out a spreadsheet showing the current charges per municipality, what the charges would be if increased by 5¢ per parcel, and the charge if we would use a flat fee increase of \$150.00. Ms. Brown added that the last time there was an increase was in 2006, that

the cost of the functions (i.e. bank charges, trips to the post office, etc) are the same for her office no matter the size of the municipality, and so in her opinion a flat fee would be the more fair way to go.

Supervisor Podzilni moved increase the flat fee rate, second by Supervisor Beaver. FAILED on the following vote: AYE – Supervisors Podzilni and Beaver; NO – Supervisors Kraft and Mawhinney.

Supervisor Kraft moved to increase fees by 5¢ per parcel, second by Supervisor Mawhinney. ADOPTED.
