Updates.

Review and Approval of Vehicle Service for Council on Aging to Gordie Boucher Moved by Supervisor Pleasant to approve the bid for vehicle service to Gordie Boucher through December 31, 2019, second by Supervisor Owens.

Ms. Lubben said the vehicle repair service went out for bid and Gordie Boucher came back substantially lower.

Chair Richard asked how much was usually spent per year on vehicle service. Ms. Lubben said it is just under \$100,000.

<u>Council on Aging Department Update</u> Ms. Lubben said the Cycling Without Age program training went very well. She said the Bike Federation people gave a three hour training session on piloting the trishaws. Ms. Lubben said she is in the process of a contract with Huntington Place to store the trishaws.

Ms. Lubben said the Aging Plan is still in process with GWAAR, the public hearing will be September 7, and then it will come back to this Committee.

Ms. Lubben said the State Patrol did their annual inspection of the transit vehicles and they all passed.

Ms. Lubben said she is applying for grant funds for three new vehicles as all the vehicles are in excess of 160,000 miles.

Ms. Lubben said she is working on the five year Rock County Transportation Plan, which should be done in September and will then go to the Wisconsin Department of Transportation.

Ms. Lubben said the Senior Fair will be held Friday, September 14 at the Holiday Inn Express in Janesville, and on Tuesday, October 2 at the Eclipse Center.

Ms. Fillhouer was not able to make the meeting.
