

## EDUCATION, VETERANS AND AGING SERVICES COMMITTEE Minutes – September 28, 2017

<u>Call to Order</u>. Chair Richard called the meeting of the Education, Veterans and Aging Services Committee to order at 5:31 P.M. on Thursday, September 28, 2017, in the Committee Chairs Conference Room, fourth floor, Courthouse East.

<u>Approval of Agenda.</u> Supervisor Owens moved approval of the agenda, second by Supervisor Pleasant. ADOPTED.

<u>Approval of Minutes – August 15, 2017.</u> Supervisor Schulz moved approval of the minutes from August 15, 2017, second by Supervisor Owens.

Supervisor Schulz moved to amend the minutes as follows under <u>Discussion of Federal Budget Impacting Aging, Veterans and RSVP Budgets.</u> ". . . The committee agreed and Supervisor Schulz will draft a letter. The Department will work to make bikes available to all facilities around Rock County.", second by Supervisor Owens. ADOPTED.

<u>Citizen Participation, Communications, Announcements, Information.</u> Mr. Solis reported that his office was involved in a week-long training last week which was very beneficial. The new State VA Secretary was present and was well-received.

Supervisor Schulz promoted a diabetes program available through the Second Harvest organization that provides \$25 food stipends and educational materials. The organization has 34-40 slots available. Chair Richards suggested that this be announced at tonight's County Board meeting.

**Review of Payments.** The committee accepted the report and the Committee will be updated at the next meeting on a bill for the Council on Aging - Fagan Automotive in the amount of \$15,271.53.
