Department Reports.

Economic Impact of VA Benefits in Wisconsin and Rock County. Mr. Solis stated that there was recent proposed legislation that would have made drastic changes to Veterans benefits at the local level. The bill did not pass but Mr. Solis wanted to make the committee aware of the impact that the Rock County office has in the community. The Veterans Service Office assisted local veterans in 2014 with \$61 million in compensation, pension and health care benefits. In 2015, the office assisted with \$32 million in VA home loans.

<u>Ideas for Future Discussion.</u> Supervisor Richard stated that he is still attempting to set up a liaison with the new UW Rock County Chancellor.
