## Department Reports.

<u>Veterans Services – Brief Success of Wisconsin Veteran's Property Tax Credit</u>
(PTC) in Rock County – John Solis Mr. Solis said the tax credit used to cover those Veterans 65 years of age or older and under the new schedule it will cover all Veterans at any age. There have been reimbursements totaling in excess of \$132,000 since the first of the year.

<u>RSVP - Program Updates - Robert Harlow</u> Mr. Harlow said the 38<sup>th</sup> Annual Recognition Dinner was held June 16<sup>th</sup> at the Janesville Moose Lodge and they had about 300 people in attendance.

Mr. Harlow said the Seniors Volunteering for Seniors program is now serving 170 people. Mr. Harlow said he is very pleased with the progress of the program.

<u>Council on Aging – Non-Emergency Medical Assistance Transportation Brokerage – Joyce Lubben</u> Ms. Lubben said effective July 1st there will be a big change when the Department of Health Services (DHS) will implement a new transportation management system that will coordinate non-emergency medical transportation (NEMT) services statewide. The DHS has contracted with LogistiCare Solutions, LLC to provide NEMT management services for Medicaid and BadgerCare Plus members. LogistiCare will act as a medical assistance broker and contract with local transportation providers across the state through common carrier, specialized medical transport and volunteer driver systems.

Ms. Lubben went over the report, which gives an explanation and considerations of the program. Ms. Lubben said staff recommendation is not to go with LogistiCare as there are many unknown factors in working with them, any revenue generated from this contract would not reduce county tax levy, and this would then open opportunities for them to expand service to the elderly and persons with disabilities beyond medical trips.

Supervisor Wopat moved to not go with LogistiCare Solutions, LLC, second by Supervisor Gustina. ADOPTED.

<u>Semi-Annual Report of Training Costs Exceeding \$1,000 per Employee per Event.</u> The Committee accepted the report and asked to have it placed in the file.

## Committee Requests and Motions.

<u>Ideas for Future Discussion</u> Chair Thomas asked to have Landscaping at UW-Rock County and Youth in Government on the next agenda.
