As part of the 2015 budget, the Land Information Office is scheduled to purchase a wide format HP DesignJet plotter to replace the current wide format DesignJet model 4500 which was purchased in 2009. This T1500 DesignJet will be installed in the Planning Department on the second floor of the Rock County Courthouse in room 266. This plotter will be used to print maps and documents of various sizes and complexity for the Land Information Office. The DesignJet will be connected to the Rock County network and Information Technology has agreed to assist with the installation of the hardware and software required to run such this technology. The cost of the DesignJet is \$7,719.45 and includes the DesignJet with stand and a 5 year next business day maintenance contract.
