- 1) Call to Order. Chair Nelson called the meeting to order at 9:25 A.M.

- 6) <u>Approval of Agenda.</u> Mr. Meyer moved approval of the agenda, second by Mr. Enger. ADOPTED.
- 7) <u>Approval of Minutes of June 15, 2016.</u> Chief Zibolski moved approval of the minutes of June 15, 2016, second by Ms. Luster. ADOPTED.
- 8) Discussion about Evidence-Based Decision Making (EBDM) Initiative and Finalization of Phase VI Application. Ms. Pohlman McQuillen said that our next meeting is scheduled for Aug 17th. We will not know if we are accepted for Phase VI until September. Is there a need for the August meeting? The committee agreed to cancel the August meeting. Our next meeting will be held on September 14th.

Our Phase VI application is due to the state on July 22nd. Tuesday, July 26th will be a state CJCC meeting to approve the full state application. Ms. Pohlman McQuillen thanked everyone that completed the survey to assist in filling out the application.

<u>Scorecard review</u> - Today we need to quantify our impacts. Ms. Pohlman McQuillen handed out the rough draft of our scorecard and an impact example sheet. She said she got great feedback from Mark Carey about our scorecard draft. Ms. Pohlman McQuillen said she referred to other jurisdictions to come up with baseline numbers on the scorecard. We currently have no baseline data for recidivism. The committee had a short

discussion again on the definition of recidivism. It was agreed that for the purposes of the scorecard that we will keep it simple.

Chief Zibolski said that he is working on getting Beloit municipal court data. The committee agreed that the word 'convictions' would also include forfeitures. The committee agreed to modify the date on the scorecard from 2018 to 2020 for "25% decrease in disproportionate minority population in Rock County Jail". We will define this at a later meeting.
