#### Executive Summary Amending the Sheriff's 2016 Budget to Purchase Optics and to Upgrade Rifle

Since late last year, EOTech, a manufacturer of holographic weapons sights, has been accepting customer returns of certain EOTech weapons sights affected by one of several performance issues. EOTech has instituted a program for purchasers of affected sights to obtain a refund of the purchase price at the customer's option.

The Sheriff's Office returned their weapons sights to EOTech. EOTech sent a refund check for \$6,809 which was booked to 21-2100-0000-46900, Refund of Prior Year's Expense.

The Sheriff's Office will purchase replacement optics from Vortex Optics of Middleton, WI. The optics will be purchased directly from Vortex Optics at a law enforcement discount of forty percent off of retail price. The cost will be \$4,848.

The remaining refund amount of \$1,961 will be used to upgrade the rifle that is already in the 2016 Capital budget.

Request to Sell File Cabinets as Scrap Outside of a County Auction

Over the past few months, we have been selling the surplus items stored in the old Rock Haven building on-line through Wisconsin Surplus. Items have been selling fairly well and we will continue doing these on-line auctions until all of the items are sold. We have been putting items that are still useful in a separate room and departments have been taking these items as needed.

Some of the remaining items are not in good enough shape to sell on-line and we would be better off selling them as scrap. Items include metal filing cabinets that the drawers are stuck, dented and rusty and old army surplus "tanker" desks. The file cabinets that we did sell on-line have gone for an average selling price of \$5.00. This is consistent across the board on the various surplus websites. Additionally, the tanker style desks are really a tough item to sell. Shilo has done a lot of searching on the Internet and most don't sell at all. We would get approximately \$1.00 per desk if we scrapped them locally. Also, we would have to load them all and get them to the scrap company. They are extremely heavy and awkward and would be tough for us to move. I think it's too time consuming and dangerous for us to have staff and/or recap inmates do.

We have an interested buyer who will come to Rock Haven and load all these scrap items onto his own vehicle with no help from any county representatives. This buyer is offering us much more than we could get on any surplus site (see attached). The cost and staff time it takes to go to the building, take pictures, measure and label each item, drive back to the office, type all the information up and then send to the surplus website far exceeds the costs of what we could recoup in selling them online. I conservatively estimate for our time alone would cost approximately \$400.

I am asking your permission to sell the items the scrap dealer who will come on-site to load and haul away at the price outlined on the attachment. Your consideration is greatly appreciated.
