The following were speaker's comments:

Gary Bersell, Executive Director, Kandu Industries Inc.:

Thank you to the DD Board for their continued support. Kandu serves 200 clients daily. They have increased their fund raising to help offset the tight budget. They are adding new shifts as clients are working at the maximum hours per day. Kandu is serving 4-6 clients per year without DD Board funding. Kandu has not seen any "down" time in 3 ½ years.

Jennifer Pelz, CESA 2 VOA

Concern for losing long term support funding due to 22 clients not having the functional screening done by the ADRC. Asking for time consideration for the clients to be screened. It is up to the clients to contact the ADRC to get this done.

Linda Updike, Concerned Parent/Guardian:

My son is 20 years old and is on the waiting list. Concern of what programs are available to her son that is on the waiting list. Both parents work outside the home. Thanks to the DD Board for any help.
