Also emergency COVID funds may be used if available and applicable. 2) Change the time period from calendar year 2020 to the fee year of July 2019 to July 2020. 3) Include all businesses that pay license renewal fees, including body art, pools, beaches (line 3). Supervisor Aegerter moved to approve the submitted amendment, second by Supervisor Purviance. Ms. Oja said CARES funding does not cover loss of revenues, so it would be a loss to the General Fund. Amendment ADOPTED. Supervisor Purviance moved approval of the above resolution, second by Supervisor Davis. ADOPTED on the following vote: YES – Supervisors Mawhinney, Aegerter and Purviance. NO – none. ABSTAIN – Supervisors Fox and Davis.
